Dear Mr. Sears:

I believe, on reasonable grounds that, by means of mail, you are either committing or aiding the commission of an offence in that you are sending, or causing to be sent, items that include hate propaganda in contravention of Subsection 319(2) of the *Criminal Code* and/or that include the publication of defamatory libel in contravention of Section 300 of the *Criminal Code*.

Accordingly, pursuant to Subsection 43(1) of the *Canada Post Corporation Act*, I have issued an Interim Prohibitory Order, a copy of which is attached, prohibiting the delivery of all mail posted by James Sears, Leroy St. Germaine, and Laurence Victor St-Germaine doing business under *Your Ward News*, or acting through an agent, or acting under any other personal or firm name and/or style.

This is to notify you that you may, within 10 days of the date this letter is sent, request in writing that the Interim Prohibitory Order be enquired into by a Board of Review.

After receipt of such a request within the time period specified above, a Board of Review will be established and you will be advised of the date, time and place such Board will convene so that you may in person, or by counsel, appear before the Board and make representations and present evidence to the Board.

If no request is received for a review of the said Order within this 10-day period, the Interim Order shall, at the expiration of that period, be deemed to be a Final Prohibitory Order. In addition, if you request a Board of Review and fail to attend without reasonable excuse, including any adjournment, the Interim Prohibitory Order will be deemed to be a Final Prohibitory Order. Any mail intercepted as a result of a Final Prohibitory Order shall be disposed of

in accordance with the *Undeliverable and Redirected Mail Regulations*. Should you require any additional information regarding the preceding, I refer you to sections 43 to 47 of the *Canada Post Corporation Act*.

Further, I should advise you that, in accordance with Section 59 of the *Canada Post Corporation Act*, every person who knowingly does anything prohibited by an Interim or Final Prohibitory Order commits an offence.



IN THE MATTER OF SUBSECTION 43(1) OF THE *CANADA POST CORPORATION
ACT* – INTERIM PROHIBITORY ORDER

WHEREAS I have reasonable grounds to believe that James Sears is by means of mail, either committing or aiding the commission of an offence in that he is sending, or causing to be sent, items that include hate propaganda in contravention of Subsection 319(2) of the *Criminal Code* and/or that include the publication of defamatory libel in contravention of Section 300 of the *Criminal Code*.

I, therefore, by virtue of the authority vested in me under Subsection 43(1) of the *Canada Post Corporation Act*, prohibit the delivery of mail posted by James Sears or acting through an agent, or acting under any other personal or firm name and/or style.
